The fiscal year of the Indianapolis Hiking Club starts on October 1st and yearly dues are payable at that time. Dues become delinquent on December 1st and if not paid by January 1st the member becomes inactive and is deleted from the mailing list and no longer accumulates mileage. An inactive member may be reinstated upon payment of the current dues.
